Your Comment:

Hi D57 Board, Thank you for serving and continuing to volunteer; this task can not be easy. If you were wondering what the community's views on masking, etc are, I am offering mine. I would prefer masking be up to the parents; a choice made in the best interest of the child. I feel the same way about vaccines, what a child eats for lunch, how a child wears their hair— everything. I do not believe in a one-size fits all protocol. Every kid is different. For perspective, my kids are vaccinated against everything available, including COVID. This was the right choice for our family (I hope). My D57 kid will be masking indoors in school because right now that is what his body needs. However, I believe it is unreasonable of me to expect all the other kids he encounters all day to do the same. A mask or a vaccine may be an unnecessary risk for his classmates. They should not have to jeopardize their health/belief system to accommodate my child's health and our family's belief system. I don't believe my husband and I are the only, parents who feel this way. Are we stuck with mask mandates, etc because of the governor and ISBE? Is my breath wasted here? Should I be taking my complaining higher up? Please let me and the community know. Thank you for listening..

Dear Board Members, Please ask administration to share specifics about the ventilation and air purification at Lincoln, It is a very old building and a very old ventilation system. Parents have been trying to get the answers to the following questions and have not received complete answers yet. Will fresh air (from outside) be brought into the classrooms via the ventilation system at Lincoln, or will it be all recirculated air? 2. How many air exchanges per hour will there be in a typical classroom at Lincoln? 3. What level filters are being used at Lincoln? 4. What does a photohydroinoinzatio component do in the air handling units at Lincoln? How much filtration will this provide? How much does it improve the air? Are there any health or safety concerns regarding the ionization this system can generate? 5. What are anodizers and which rooms will they be in? How much filtration do anodizers provide? 6. Will there be HEPA air purifiers in classrooms? If so, which classrooms? Scientists say there needs to b 6 air exchanges per hour. And theat MERV 13 filters should be used in schools. We have been told that Lincoln is only using MERV 4 and do not have an answer regarading air exchanges per hour. Scientists say that putting a HEPA air purifier in each class room can help compensate for older ventilation systems. Doing this would provide greater safety for students and keep the oppotunity for in person learning with fewer quarantines. Please ask administration to get thiese answers ASAP, and not wait until the next board meeting. Thank you.

Hello, so exciting the kids are back at school. I just have a quick inquiry. Is it possible for the kids to eat lunch outside (weather permitting)? This could allow for more socialization and safety. As well as not dealing with assigned seating. I know other districts nearby are having outdoor lunch (Park Ridge). Thank you!

Hello, I just wanted to ask if there is any need to test or quarantine after travel outside of Illinois. With the rising cases in some states I would ask that you consider creating a policy regarding if a student, teacher or staff member traveled to an area with substantial community transmission.

I have one final note I forgot to mention in my last message regarding the shield testing. Can you please speak to the validity? The CDC recently announced that the pcr test would not be allowed come December. It was determined that it was not accurately recognizing the difference between covid and the flu. How that inaccurately effected the statistics is concerning. Is this shield test the school wants to use the same as this faulty pcr test?

As the next meeting approaches, I hope that details are shared about this covid testing that the superintendent mentioned. I am hoping this is an open discussion and that the children of parents who may want to opt out are not penalized. I saw a testing option on the Illinois department of public health website for children who were identified as a close contact. It appeared as a nice option to avoid having to quarantine. I think many parents would be opposed to regular testing of asymptomatic children aside from those identified as a close contact. CDC has not definitely indicated that the asymptomatic can transmit this virus. I believe this could lead to unnecessary quarantining of children. Medical testing in a school setting could also cause a lot of anxiety for children. Is this something that the majority of parents want? I would ask that you poll the parent and please give the community of parents the power. Thank you for your time.

District 57 School Board members, thank you for continuing to work to support safe in-person learning environments for our students. As the number of COVID-19 cases and hospitalizations in our community continues to rise, I applaud your efforts to adopt a universal masking policy for all unvaccinated persons even before the Governor's announcement. You were right on. I am also glad you are exploring a screening test option to provide another layer of prevention in schools. We know in-person learning is critical and we're ready to do whatever it takes to keep kids learning in-person including vaccination, masks, screening testing, physical distancing, etc. No one mitigation strategy is sufficient to protect students while infections are on the rise so thank you for implementing several strategies. Please continue to prioritize safety while finding ways to keep kids in school. I know this is a challenging time for students, families, and board members. I appreciate your service to the community.

The Covid 19 Dashboard (https://www.d57.org/covid-dashboard.aspx) is using different metrics and categories for transmission than the CDC as outlined in the ISBE/IDPH document at the following link: https://www.isbe.net/Documents/ISBE-IDPH-School-FAQs-20210809.pdf Per this document, "CDC defines community transmission as low, moderate, substantial, or high..." With low transmission being 0-9.99, moderate being 10-49.99, substantial being 50-99.99 and high being greater than 100 cases/Total new cases per 100,000 persons in the past 7 days. The D57 dashboard uses, minimal, moderate, moderate and substantial language and the numbers for categorization are different. Will D57 be updating their dashboard prior to the school the year to match the transmission category definitions from CDC? If not, can someone please direct me to whom to contact to discuss why we're using different definitions so I can better understand why?

Dear Members of the Board and Dr. Gorr, I hope you have had a relaxing summer. It's hard to believe school will begin next week. Time certainly flies. To review, I have three students in D57. An 8th grader at Lincoln, as well as a 5th and 2nd grader, at FV. I am including the link to an article that covers a speech that was given by a health professional to a local school board in Indiana. The speech summarizes multiple research studies surrounding Covid, as as well as, references the doctor's own experience treating Covid patients. The article provides multiple links to the research. I do believe that the board is working hard to apply recommendations from our local health departments in order to protect students and staff. However, research has, and continues to, demonstrate that citizens must evaluate whether CDC is fully reflecting research in it's recommendations. I don't blame you for relying on the health departments recommendations. No one on the board is a health expert. That being said, it is imperative to your position to look at all the evidence that is placed before you. If you are concerned about backlash for the deviation from these recommendations due to the desire to apply the evidence based research, then consider the support you would receive by me, and so many others including health professionals, that would have your back. Dear Members of the Board, ISBE has now put out updated guidance that clearly recommends universal masking regardless of vaccination status for all students and staff at K-12 schools. https://www.isbe.net/Documents/ISBE-School-FAQs-20210802.pdf "4. Who should wear masks in schools? Everyone. IDPH and ISBE endorse the CDC recommendation that all teachers, staff, students, and visitors to K-12 schools wear a mask while indoors, regardless of vaccination status." This is in response to new CDC guidance due to recent information that unlike previous variants of covid-19, vaccinated individuals experiencing breakthrough infections of the Delta variant carry similar levels of virus in their noses and air passages to those of infected unvaccinated individuals, and they can similarly transmit the virus to others. (https://www.cdc.

gov/media/releases/2021/s0730-mmwr-covid-19.html) The CDC is also recommending universal masking for vaccinated and unvaccinated individuals in all indoor settings in areas of substantial and high community transmission due to the Delta variant, which now includes Cook County and Mount Prospect (MP 85.3 cases per 100,000 https://covid-dashboard.fsm.northwestern.edu/ https://covid.cdc.gov/covid-datatracker/#county-view). Two other local districts (D21 Wheeling and D63 East Maine) have switched from a "vax or mask" plan to a "masks for all" since the revision of the CDC guidance on July 27. Many local businesses, park districts, libraries, etc. are doing the same. Last night, D59 Elk Grove voted to start the year requiring universal masking, in part because the new ISBE guidance clearly advantages schools with universal masking in having fewer and shorter guarantines. "According to the new CDC close contact definition, classroom students who were within 3 to 6 feet of the infected student are not treated as close contacts as long as both the infected student and exposed student were engaged in consistent and correct use of a well-fitting mask and other K-12 school prevention strategies (such as universal and correct mask use, physical distancing, increased ventilation) were in place in the K12 setting." The quarantine period is for 14 days but can be reduced to 10 or 7 days under certain conditions, one of which is "The individual can maintain physical distancing and masking at all times when returning to school; for classrooms where masking is strictly adhered to, physical distance of 3 to 6 feet is acceptable for return". There is also a "test to stay" option that avoids guarantine with every other day testing but "Test to Stay is only applicable when both the COVID-19-confimed student and close contact were engaged in consistent and correct use of well-fitting masks and the school requires universal indoor masking for all individuals (age 2 and older), regardless of vaccination status, as recommended by the CDC." District 59 did a very succinct slideshow explaining how a universal masking rule helps keep children in school. Screenshots of the slides are here: https://docs.google.

Please align with guidance from the CDC, AAP, IDPH, CCDPH, and ISBE and require masks for all staff and students at our schools regardless of vaccination status to start the school year. Please do this for the health of our students, staff, and community, and to have the best chance of keeping students in school and the least disruptions as we start our new school year. Please also consider taking advantage of the free SHIELD covid testing program, which uses non-invasive (saliva) testing and provides staff to implement the testing. This provides another layer of mitigation as we reduce other layers by having more students in school, reducing distancing, ending cohorting (D21 will continue cohorting through 6th grade), resuming normal passing periods and use of lockers, and beginning to use cafeterias again, while we start school with a more transmissible strain of the virus in circulation. This also would provide the possibility of keeping more students in school using the "test to stay" protocol in cases of close contact. D59, D26, D15, D21, and D63 plan to implement SHIELD testing. D23 is also investigating its use. I appreciate all that the Board and District have done to keep our students safe. Please continue to respond to changing guidance and make the best decisions for the well being of our students and staff. Thank you, Pam Koerkel

Hello School board, I know there are many parents that feel that the use of masks on our children should EITHER be parental choice OR to be masked while indoors except for lunch. I feel it is unfair to ask the staff to have to police which children should be masked and which one should be. They have enough to do and worry about as it is. Would it be possible to make class assignments at Westbrook, Lions Park and Fairview based on Mask preference? Can they cohort the classes now splitting up the masked and unmasked? It would be great to not have to resection classes throughout the year because of changing guidelines. I know this doesn't help at Lincoln but maybe it could work in the other 3 schools. Just a thought. Also would the schools benefit from having an air purifier in their rooms and position it near where the teachers would hold small group sessions? I would be happy to donate money or set up a fundraiser to help buy the classrooms an air purifier. Thank you for your time and consideration and for all that you do for our district. I truly appreciate it.

Good Afternoon Dr. Gorr, District 57 Administration and Board of Education, Thank you for all you and the staff have done over the past year and a half to plan and adjust for the safety and education of our students and community. Thank you for also prioritizing masking for the start of the school year while many students are unable to be vaccinated. I've put off sending this note, because I truly appreciate how much is on everyone's plate now and the increasingly challenging and ever changing circumstances. I had hoped there would be updated guidance that addressed some of my concerns. I'm writing to ask that you continue to layer mitigations and add mitigations to start the year as safely as possible. I hope that you strongly consider and implement Shield testing, increased ventilation / air purification, follow Cook County travel guidelines along with having lunch outdoors as much as possible as weather allows (and consider adding tents for lunch). With increasing cases of a more transmissible variant, increased summer travel, family celebrations and coming together again indoors in larger groups - it makes sense to be cautious and to adopt as many layers as possible to protect the health and safety of all in our schools and community. Ideally I would hope that families would test prior to the start of school so we can have the safest start possible with increased summer exposures. Unlike the spring transition to in-person learning with decreasing cases and nationwide restrictions in place, less restrictions, summer travel and the Delta variant have changed the circumstances yet again especially for our unvaccinated children in a school setting. If Shield testing is not something that can be offered or implemented by the start of the school year, I hope that there might be a partnership and some specific direction for families on the easiest, guickest and most convenient way for them to test when needed and to encourage testing before the start of school. Most of the State of Illinois testing sites are only open during business hours which does not support community surveillance testing as children in school at those times. Air filtration and ventilation is a lasting investment in creating a healthier school environment for years to come. If additional air purifiers are needed I see this as something the community could assist with and invest in if there is not available funding. (I would happily contribute to a fund or purchase something needed for the school). Lastly, I want to note the emotional toll the pandemic has had on all, including our children. We have all adapted so much and continue to do as much as we can to navigate this time in a safe and considerate manner. I hope that there will be focus in school on acknowledging the losses and challenging times our children are experiencing. Thank you for your time. To the Members of the District 57 Board of Education: I am writing today to urge you to change your decision regarding masks in schools. It is imperative that we align with the updated CDC and IDPH guidance that recommends masks for everyone in the school setting regardless of vaccination status. I understand that many districts are probably waiting for more clear ISBE guidance which may emerge before the beginning of the school year. However, we will have students in our middle school for summer band and orchestra starting this coming Monday, and I have been informed that we will be following the previous Board decision for 2021-2022 school year regarding requiring masks only for the unvaccinated, which aligned with the previous CDC and IDPH guidance. My vaccinated band student will be wearing a mask and is unlikely to have severe covid if she contracts it from another unmasked student at band, but new evidence shows that she could still transmit it to vaccinated and unvaccinated (due to age) family members. Since the last board meeting, the CDC has issued new guidance for all staff and students to wear masks in K-12 schools regardless of vaccination status, which was adopted fully by IDPH, and Cook county has just moved into substantial transmission. Some school districts have recently stated that they will be adopting the stricter "masks for all" for summer school and activities until they have had more time to review the changing guidance and make decisions about the start of school. In addition, communication has not gone out to families about providing proof of vaccination, or what to do if a student has symptoms now that they will not be flagged by daily self-certification and how they will be cleared to return after a covid-like illness. Dear Board Members and Superintendents, This letter details the violation of students' legal right to an education and the unconstitutional overreach of the elected school board officials and paid employees to mandate health requirements, specifically masking and quarantine/vaccination segregation for the school year 2021/2022. Individual board members may be held legally responsible and liable for violating constitutional laws since they are not healthcare professionals. School board members are not protected by qualified immunity, and they have allegedly violated civil and criminal laws, and can be held responsible individually along with the superintendent. As of July 1, 2021 the school board has the authority to determine all return to school plans. We ask that the school board implement an optional face mask form for students for school year 21/22. An opt in/out form will provide parents/guardians control over their student's medical needs. In addition to a face mask form, the school board should not adopt any guarantine/vaccination segregation of non-vaccinated students for school year 2021/2022. In consultation with legal counsel, they have outlined the following violations of constitutional and state law. Illinois School Code is extremely specific regarding laws passed by the legislative branch of the state and adopted into school board policy. FACE MASK LAW 1. There is currently no state law in Illinois enacted by the Illinois Legislature, or any Administrative Rule enacted that requires any individual, including students, to wear a medical device otherwise generally known as a face mask in order to prevent any illness, including but not limited to any contagious or infectious disease, virus, etc. 2. There is no lawful authority, neither State nor Federal, that has the ability to lawfully and legally require any individual in a private setting, in a public place or within an individual's workplace or place of employment or in a school, a school classroom or any school property to require any individual to wear a medical device otherwise generally known as a face mask in order to prevent any illness, including but not limited to any contagious or infectious disease, virus, etc. ISBE AUTHORITY 3. The Illinois State Board of Education, School Superintendents, School Boards, teachers or any other Illinois educational personnel are not medical nor health care professionals, licensed in the State of Illinois to perform medical diagnosis or prescribe remedies, medical interventions, etc. and therefore have no lawful or legal authority to require any individual or student in a school, a school classroom or any school property to wear a medical device otherwise generally known as a face mask in order to prevent any illness, including but not limited to any contagious or infectious disease, virus, etc. pursuant to 105 ILCS 5/2, Illinois School Code, State Board of Education - Powers and Duties. IDPH AUTHORITY 4. The Illinois Department of Public Health (IDPH) does not have the lawful and legal authority to mandate, require or force any individual to wear a medical device otherwise generally known as a face mask in order to prevent any illness, including but not limited to any contagious or infectious disease, virus, etc. and to do so is unlawful and acting outside their statutory authority pursuant to 20 ILCS 2310-15. 2 / 3 5. Further, any and all IDPH guidance, suggestions, orders or directions provided or given to Illinois Schools, the Illinois State Board of Education (ISBE) or Illinois School officials, Boards or Superintendents regarding school health care policy, measures or safety precautions, school attendance procedures, or face mask or facial covering requirements is 100%, unequivocally, without question or contemplation, unlawful and illegal. In 1897, in Potts v. Breen, the Illinois Supreme Court ruled that: "While school directors and boards of education are invested with power to establish, provide for, govern and regulate public schools, they are in these respects nowise subject to the direction or control of the State Board of Health" CDC AUTHORITY 6. The CDC (Centers For Disease Control) is an advisory agency to the Executive Branch of the United States Government; it is an advisory agency only and possesses no rule making authority, federally or within the 50 states of the United States of America, and has no authority to lawfully or legally to mandate or require any individual, including students, to wear a medical device otherwise generally known as a face mask in order to prevent any illness, including but not limited to any contagious or infectious disease, virus, etc. BAILEY V. PRITZKER RULING/AUTHORITY 7. On July 2, 2020, a Clay County, Illinois Court ruled in a Class Action case, Bailey vs. Pritzker (20CH06), that the Illinois Governor had no Constitutional nor legal authority to issue any Executive Orders after April, 2020, pursuant to the IEMAA and as such any Executive Orders issued were unconstitutional and "void ab initio". This Illinois Court Order continues to be valid and is currently applicable. EXECUTIVE ORDER 2021-10 8. The Governor's recent Executive Order, 2021-10, that attempts to further expand, or intended to continue, renew or reiterate any mitigation or restrictive policies previously stated regarding movement or health-related measures or that requires any individual in a private setting, in a public place, within an individual's workplace or place of employment, a school, a school classroom or school property to wear a medical device otherwise generally known as a face mask in order to prevent any disease, virus, etc. or defer such authority or rule-making to the IDPH or the ISBE, violates the Bailey Court Order and is unlawful and has no legal authority. COVID VACCINE STATUS/FDAAUTHORITY 9. The COVID vaccine is an experimental, FDA unapproved medical treatment and is only authorized for use pursuant to the Emergency Use Act (21 USC 564(b)(1)(C)). Therefore, the FD&C Act, 21 U.S.C. 360bbb-3, regulates the use and the administration of that experimental, unapproved treatment and states: . the option to accept or refuse administration of the product, of the consequences, if any, of refusing administration of the product, and of the alternatives to the product that are available and of their benefits and risks." Therefore, every individual has the right to refuse any vaccine authorized under the EUA. VACCINATION ID CARDS 10. Vaccine Identification cards issued by local health care personnel as the result of being administered a vaccine that is not lawfully mandatory are not a legal document and have no legal or authoritative value. As well, these vaccine ID cards contain personal and private health information protected by federal law pursuant to the HIPAA Privacy Rule, 45 CFR Part 160 and Subparts A and E of Part 164, and specifically Rules number 1 and 18; that personal identification information is private by federal 3 / 3 definition and protected pursuant to federal law and not required to be disclosed unless by voluntary consent. ILLINOIS HEALTH CARE RIGHT OF CONSCIENCE ACT 11. Pursuant to 745 ILCS 70/1, Sections 2,5 and 7, the Health Care Right of Conscience Act, states: "Sec. 2. Findings and policy. The General Assembly finds and declares that people and organizations hold different beliefs about whether certain health care services are morally acceptable. It is the public policy of the State of Illinois to respect and protect the right of conscience of all persons who refuse to obtain, receive or accept, or who are engaged in, the delivery of, arrangement for, or payment of health care services and medical care whether acting individually, corporately, or in association with other persons; and to prohibit all forms of discrimination, disqualification, coercion, disability or imposition of liability upon such persons or entities by reason of their refusing to act contrary to their conscience or conscientious convictions in refusing to obtain, receive, accept, deliver, pay for, or arrange for the payment of health care services and medical care." "Sec. 5. Discrimination. It shall be unlawful for any person, public or private institution, or public official to discriminate against any person in any manner, including but not limited to, licensing, hiring, promotion, transfer, staff appointment, hospital, managed care entity, or any other privileges, because of such person's conscientious refusal to receive, obtain, accept, perform, assist, counsel, suggest, recommend, refer or participate in any way in any particular form of health care services contrary to his or her conscience." "Sec. 7 Discrimination by employers or institutions. It shall be unlawful for any public or private employer, entity, agency, institution, official or person, including but not limited to, a medical, nursing or other medical training institution, to deny admission because of, to place any reference in its application form concerning, to orally question about, to impose any burdens in terms or conditions of employment on, or to otherwise discriminate against, any applicant, in terms of employment, admission to or participation in any programs for which the applicant is eligible, or to discriminate in relation thereto, in any other manner, on account of the applicant's refusal to receive, obtain, accept, perform, counsel, suggest, recommend, refer, assist or participate in any way in any forms of health care services contrary to his or her conscience" A citizen's Individual Medical Choice to refuse to wear a facial covering or face mask, to refuse or reject an experimental and FDA unapproved and untested medical treatment by way of vaccine, or a parent or guardian's choice to exercise the same for a minor child or children is a protected individual medical and conscience choice and right and is protected by Illinois law and shall not be violated or infringed. It is now the burden of the districts legal team to provide statues or codes that counter the ones we laid out in this letter. Respectfully, Concerned Parents

I just came to leave a quick comment that I support the way the Board voted on Thursday regarding masking. It's my understanding (please correct me if I'm wrong) that you (the Board of Education) have some flexibility in how you handle mask rules, but you have no flexibility on the quarantine rules. That being the case, if you had made a different decision regarding masks, such as "parents' choice", then (based on the new CDC definition of "close contacts" in a K-12 school setting) unvaccinated people without masks would absolutely have a negative impact on the number of people that would have to be quarantined if there is a positive case. I understand that Dr. Gorr noted that more clarification is needed on that new exception. If it does hold with IDPH, then I think that your vote outcome on Thursday was to maintain the safest and most consistent learning environment possible. This will minimize disruption, because quarantine is so very disruptive to learning. Anything we can do to minimize having to quarantine is a good thing. All that said, I do hope that some sort of "goal line" can be established as to when it might be safe to drop masks. Maybe that's not the Board's place to establish, but it's something to consider. I don't think anyone wants masking to go on indefinitely, but I agree that now is not yet the time to remove that precaution. I just hope that you're pondering the question of "when?". It sounds like you plan to re-evaluate this decision periodically, which I think is always a good idea. As always, I thank you for your tireless time and efforts on the Board.

As the parent of two D57 students, I am writing to recognize and thank you for the district's decision to require face coverings for students and staff who are not fully vaccinated. I know this is not a popular stance and I want you to know that there are many parents and families that appreciate the district's position. You may not hear from all of these families that assume this was the easy choice since it is supported by public health and healthcare experts. Please don't forget that these families are out there when you hear from a very vocal contingent that will not be happy until schools and other venues have no COVID-19 prevention measures in place. We will get to that point but we're not there yet! Your decision to make face coverings a requirement for those not yet fully vaccinated provides a strong incentive for staff and families to consider being vaccinated. The evidence from CDC is clear; protection from COVID-19 through vaccination is much safer and more effective than risking protection through infection. The decision to require face coverings for those who are not vaccinated will also help to avoid students being impacted by quarantine if exposed to a case at school. The CDC's updated definition of close contacts for K12 settings means that when both students are wearing masks, the contact does not need to quarantine if exposed to a case! This was one of the major issues for families last year so the mask requirement should be good news for anyone concerned about students missing in-person learning. Keep the masks until children under 12 have the opportunity to be vaccinated. A parent's "right" to decide their child does not need to wear a mask clearly ignores the fact that masks work both ways - 1. to protect the wearer from disease AND, 2. to protect those around the wearer in the event that person is asymptomatically infected. Information cited by CDC says that between 16% and 50% of pediatric cases may be asymptomatically infected (https: //www.cdc.gov/coronavirus/2019-ncov/hcp/pediatric-hcp.html). I appreciate your work. This has been a challenging period of time for everyone, including school board members. Dear D57 Education Board Members, My name is Braun Reyes, and I am a father of 3 students who attend school in District 57. First, I would like to thank you for all your hard work and for taking time away from your families to volunteer on our board. The last year and a half was very tough on the community and you all continued to represent us well in the face of a lot of challenges. The topic of "returning to school in the fall with masks required for unvaccinated students and staff" was discussed and an initial decision was made. I feel that the right decision was made and I also agree with the strategy of ongoing reassessment of that decision as new data and recommendations are made available. As this topic continues to be discussed, which is a decision that affects my children and family, I would like to recommend a few changes in how evidence is presented and debates are had. 1) I do not think it is appropriate to use "opinion pieces" as basis for decision making that affect the potential health and well being of our children. Member Bull referenced the following article from mymag.com: https://nymag.com/intelligencer/2021/07/thekids-were-safe-from-covid-the-whole-time.html, as evidence supporting a potential decision to make masks optional. Though this article does reference scientific findings and other data points, it is not the opinion of a medical professional. The author, David Wallace-Wells is not a medical professional. He is a journalist with a degree in history and is not qualified to be a person upon which we base our community health decisions on. We should continue to use the opinions of medical professionals and organizations such as the CDC, IDPH, and the American Academy of Pediatrics. An alternative to using unsubstantiated information and in conjunction with health departments would be to commit to certain metrics that would warrant making masks optional, such as cases per 100k or by bringing in local pediatricians to present opinions on the matter. The decision to return to school last school year was made anchored by the recommendation of distance requirements by the AAP and the detailed opinion from a pediatrician, who was also a strong proponent of wearing masks indoors, that attended that meeting. Saying an article or study came from "New York Magazine, so it must be valid" is not appropriate and we as a community deserve better representation in that regard. 2) When we compare ourselves to other districts and the decisions that they are making, let's present the full set of facts and not just those to favor one side of the debate. In making another point in favor of making masks optional, Member Bull referenced the school district in Barrington and their decision to make masks optional. This was only a portion of the facts. Per the article from CBS: https://chicago.cbslocal. com/2021/07/16/barrington-school-district-220-mask-policy/, the decision to make masks optional was only for grades 6 through 12. That decision is not too far from your own decision to vote in favor of requiring masks for unvaccinated Lincoln students. When the community is watching these proceedings, I believe they are looking for information as well as guidance. When facts are omitted to garner support for a particular option, debates are not being had in good faith. Sharing the actions of other districts is a great way to frame problems and potential solutions, but only within the context of all the facts. 3) When engaged in discussions/debate, perhaps there is a way to set a better example in how tactful those discussions are. Finally, I would like to comment on a response from Member Bull that was in direct response to an opinion expressed by Member Bennett-Kill. Perhaps because it was not clear that her reference to the "most vulnerable" meant the unvaccinated, he chose to declare that her opinion was "a bunch of nonsense". That level of attack seemed unnecessary especially after she clarified her statement. The board is an extension of our community and should set a better example. I am not sure if there are official standards for debate during meetings, but I feel that a higher level of tactfulness could have been used at that moment and hopefully is not a sign of how future disagreements are going to be handled. In closing, I would once again like to express my appreciation for all that you do. I do not pretend to represent any majority of families in expressing my thoughts. The following is a citation from the IL General Assembly: (745 ILCS 70/1) (from Ch. 111 1/2, par. 5301) Sec. 1. Short title. This Act may be cited as the Health Care Right of Conscience Act. (Source: P.A. 90-246, eff. 1-1-98.) (745 ILCS 70/2) (from Ch. 111 1/2, par. 5302) Sec. 2. Findings and policy. The General Assembly finds and declares that people and organizations hold different beliefs about whether certain health care services are morally acceptable. It is the public policy of the State of Illinois to respect and protect the right of conscience of all persons who refuse to obtain, receive or accept, or who are engaged in, the delivery of, arrangement for, or payment of health care services and medical care whether acting individually, corporately, or in association with other persons; and to prohibit all forms of discrimination, disgualification, coercion, disability or imposition of liability upon such persons or entities by reason of their refusing to act contrary to their conscience or conscientious convictions in providing, paying for, or refusing to obtain, receive, accept, deliver, pay for, or arrange for the payment of health care services and medical care. It is also the public policy of the State of Illinois to ensure that patients receive timely access to information and medically appropriate care. (Source: P.A. 99-690, eff. 1-1-17.) Furthermore, it is the right of each family to make the decision to mask their child or to not mask their child based on their own health situations and recommendations of their own physicians. The BOE does NOT have the right to dictate to all families what is best for their own child. The Health Care Right of Conscience Act supports this claim. The CDC, IDPH and ISBE fall in line with the Act by not requiring universal masking, nor do they require vaccination identification. Beyond individual rights surrounding health care, Board Members should support their positions on a factual basis supported by evidence and not emotion and fear. It is unsettling that the board is implementing a policy to a great many students to accommodate a select few parents' hysteria whose position is not supported by any real data or evidence. We need a board to act like mature adults who make decisions on rational information and to not simply react with emotion. There is huge a cost to students by focusing on fear and personal feelings rather than utilizing the real data. Member Bull set the example for this standard. You must make masking optional like so many other IL school districts are doing, including our neighbors in D25. You must not enforce vaccination identification. You are opening the district up to potential litigation. Reverse your recommendation to the Administration today.

Data is finally showing that the isolation from last year killed more young people than in years previous. The following numbers were pulled directly from the IDPH website and can be found under "Death Statistics." In 2020, 552 children ages 1-17 died. A 10% increase from the number of deaths in 2019. The increase was found in the top 3 leading cause of death; accidents (which includes overdoses), homicide and suicide. 10%!!!! Even more staggering was young adults ages 18-24, that had a 34% increase year over year from '19 to '20. Once again, accidents/drug overdoses, homicide and suicide. There was a 25% increase in ages 25-44. In 2020 there was a 67% increase in overdose deaths alone for ages 25 and under... In every single age group, there was a substantial increase in overdose deaths. D57 BOE making masks mandatory and now your segregation and discrimination?! You own this, right?

An email the following day confirmed that new parents in the district never received notification that the registration for Kids Corner had opened. I understand that the Admin team is trying to hire more staff, but when I spoke to someone at the Admin office she made it seem like they were trying, but I should really just try to find something else on my own through a private daycare. Let me tell you, this seems to be an impossible task, especially for someone new to the area, and on top of that sort of unfair since I never had a shot at getting in to Kids Corner. This Admin suggested I call KinderCare and Children's Land for before/after care. I will tell you that Kids Corner does NOT offer before and after care any longer at the Kensington Street location and Children's Land is \$225 a week for one child. Additionally, I have tried sourcing information online and have called so many daycares. Red Wagon does not do before/after. St Mark's has a waiting list. The YMCA is closed, etc. There seems to be very few to no options and I cannot afford to pay almost \$2000 in before/after care at the ONE location I found for my children. Especially when D57 Kids Corner is about \$900 a month (and no bus fee then!) As a working mom with a husband who works construction hours (too early for any drop off) I am asking that the Board helps us working parents and does not let this issue fall off their radar.
